DO NOT SIGN THIS AGREEMENT UNLESS YOU HAVE READ AND UNDERSTOOD IT IN ITS ENTIRETY. SEEK THE ADVICE OF LEGAL COUNSEL IF YOU ARE UNSURE OF ITS EFFECT.

CAMP POLICIES, PROCEDURES AND CAMPER RELEASE. WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNIFICATION AGREEMENT

In consideration for my dog being permitted to attend McNally's Dog Center (Herein after "MDC" or "Daycare & Boarding") for Daycare & Boarding I make the following representations and agree to all of the following policies, procedure, terms and conditions:

1. **DAYCARE & BOARDING REQUIREMENTS.** My dog meets the following Daycare & Boarding requirements he/she has successfully completed the behavioral assessment is spayed/neutered (if over six (6) months of age); is current on all vaccines is in good health and free of fleas, ticks and parasites with a copy of the current veterinarian records; is not aggressive or protective of toys; meets all other municipal or state licensure and other requirements; their belongings are all labeled with first and last name. I have completed the Doggie Daycare & Boarding Application and have provided MDC with Current and Valid Credit Card Number and information. My Dog will Enter & Exit MDC on leash and collar.
2. **MY DOG'S FOOD.** I understand that MDC does not feed Breakfast, Lunch or Dinner to Daycare dogs unless arrangements have been made prior. All food brought must be in a plastic container with a lid and my dog's first and last name printed on the container. As for Boarding dogs all will be fed on the MDC schedule unless arrangements have been made prior.
3. **PHOTO & VIDEO RELEASE.** I allow MDC, the owners, employees, directors and agents to use my dog's name, images and video taken while at MDC in any form, format, for use, at any time, in any media, marketing, advertising, illustration, and trade or promotion materials. I agree that this provision shall be bind on me and all my successors, heirs, legal representatives and assigns.
4. **PERSONAL PROPERTY.** I agree that MDC shall not be responsible or liable for any lost, stolen or damage personal property belonging to either me or my dog. I also understand and agree that my dog's collar may be removed in the Daycare & Boarding area to prevent injury to any dogs. If my dog causes any damage to MDC Facility or Equipment, I agree to be fully responsible for the full cost of any repair or replacement, depending on what is needed.
5. **DAYCARE & BOARDING FEES.** I agree to pay for all Daycare & Boarding fees, services and products with the credit card number I have provided in the Daycare & Boarding Application or by cash or check at the time I pick up my dog after each visit at MDC . I give my full permission for MDC to charge any of the credit card numbers I provided on the Daycare & Boarding Application for any unpaid fees, services or products. I further agree to pay the cost of any check or debit charges returned or challenges for to any reason.
6. **LATE FEES AND CHARGES.** I understand that a one (\$1.00) dollar fee will be charge for every minute I am late to pick up my dog for up to fifteen (15) minutes. If I do not pick up my dog within the fifteen (15) Minutes after closing my dog will be boarded overnight and I will be charged the overnight fee.

7. **AGGRESSIVE DOGS.** My dog is not aggressive. Although MDC loves all dogs, I understand that aggressive dogs are not permitted to attend MDC Daycare & Boarding. I also understand if my dog acts or exhibits unacceptable behavior he/she will be separated from the Daycare group. MDC will use reasonable efforts to consult parent about aggression and ways to address it, however aggressive dogs may be asked not to return to MDC. Such determinations shall be made at the sole discretion of MDC.

8. **ABANDONED DOGS.** MDC is a place where all dogs can romp and play. No Dog may be abandoned at MDC. I agree that I will not neglect to pick up my dog from MDC by the time he/she is scheduled to be picked up without providing notification prior to my delay. Any Dog left at MDC without any contact, instructions or notification failure. I understand that if I abandon my dog at MDC, that MDC will, by default, become the legal owner and guardian of the dog. MDC will, in their sole discretion, determine whether to try to rehome and adopt the dog from MDC or will relinquish the camper to an unrelated shelter of their choice. I FULLY UNDERSTAN AND AGREE THAT IF I ABANDON MY DOG AT MDC, I MAY BE UNABLE TO RETRIEVE POSSESSION OF MY DOG AND WILL HAVE NO RECOURSE AGAINST MDC AS PROVIDED BELOW.

9. **DUTY OF DISCLOSE.** I have disclosed any and all medical or other conditions, included but not limited to personality concerns or behaviors that may affect limit or prevent my dog's ability to participate in the Daycare or otherwise attend MDC.

10. **DAYCARE PARTICIPATION.** I understand that dog participation in Daycare is at the sole discretion of MDC and that dogs may be separated from other dogs or asked to leave for reasons in sole discretion of MDC.

11. **ACCEPTANCE AND ACKNOWLEDGEMENT OF CAMP PARTICIPATION RISK.** I fully understand that (a) there are inherent and potential risks involved with interactions between humans and dogs, as well as between dogs and other dogs, which may result in property damage or bodily injury, including permanent disability, sickness or death to human or dog and (b) there may be other risks not know to the owner or staff nor readily foreseeable at this time(Collectively "Risks") I fully accept and assume all risks and responsibility for all risks, including, without limitation, all loses, Costs and damages incurred as a result of me or my dog's participation in the event.

12. **VETERINARIAN LIABILITY AND CARE.** I allow MDC to obtain medical treatment for my dog, if, in it sole discretion it appears that he/she is ill, injury or exhibits any other behavior that would reasonably suggest that my dog may need medical attention. I AGREE THAT I AM FULLY RESPONSIBLE FOR THE COST OF ANY SUCH MEDICAL TREATMENT AND FOR THE COST OF TRANSPORTATION FOT=R THE PURPOSE OF SUCH TREATMENT, PROVIDED TO MY DOG.

WAIVER, RELEASE AND INDEMNIFICATION. I HEREBY EXPRESSLY AND FOREVER GENERALLY WAIVE, DISCHARGE CLAIMS, INDEMNIFY, RELEASE FROM LIABILITY, SAVE, HOLD HARMLESS AND DEFEND AND COVENTANT NOT TO USE MDC, ADVERTISERS, OWNERS, EMPLOYEES, VOLUNTEERS AND ANY PARTIES OWNING FROM AND AGAINST ANY AND ALL INJURY, LIABILITY, CLAIMS, LITIGATION, ACTIONS, SUITS, COST, LOSSES, DAMAGES, EXPENSES OR DEMANDS (INCLUDING REASONABALE ATTORNEY'S FEES)OF EVERYCHARACTER WHATSOEVER ON ACCOUNT OF, ARISING OUT OF, RESULTING FROM OR REALATING IN ANY WAY TO (a) ANY ACT OR OMISSION OF THE RELEASE, INCLUDING Negligence, AND (b) MY OR MY DOG'S PARTICIPATION IN ACTIVITIES AT MDC, OR OTHERWISE. I FURTHER AGREE TO INDEMNIFY, SAVE AND HOLD HARMLESS THE RELEASE FROM ANY CLAIMS, LITIGATION, ACTIONS, SUITS, COST, LOSSES, DAMAGES, EXPENSES, ATTORNEY'S FEES, INJURIES OR DEMANDS AS THE RESULT OF ANY SUCH CLAIM I AGREE THAT THIS RELEASE SHE BE BINDING ON ME, MY SUCCESSORS, HIERS, LEGAL REPRESENTATIVES AND ASSIGNS. I ALSO EXPRESSLY AND FOREVER RELEASE MDC FROM ANY DUTY TO PROTECT ME OR MY DOG(S) FROM THE INJURY OF ANY KIND, AND AGREE THAT EVEN IF MDC CHOOSE TO IMPLEMETN SAFETY PRECAUTIONS, SUCH ACTIONS SHALL NOT ALTER THE FACT THAT I HAVE RELEASED MDCFROM ANY DUTY TO PROTECT ME OR MY DOG(S).

I HAVE READ AND FULLY UNDERSTAND THE TERMS OF THIS DAYCARE & BOARDING POLICIES, PROCEDURES AND CAMP RELEASE, WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT AND UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT PERMITTED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID OR UNENFORCEABLE, THAT THE REMAINDER OF THE AGREEMENT SHALL REMAIN IN FULL FORCE AND EFFECTIVE. I AGREE THAT IT IS INTENDED THAT ALL TERMS OF THIS AGREEMENT CONTROL DESPITE ANY PARTICULAR STATUTE OR LAW THAT WOULD OTHERWISE PROTECT ME OR MY DOG(S)
